BOOKING TERMS AND NOTES

01. Please send your booking to your tour leader and make deposit cheques payable to MARANATHA TOURS. The deposit will be held against final payment of your holiday.
02. Kindly note that final payment is required approximately TEN WEEKS before departure from the UK - you will be invoiced accordingly.
03. Other than a material price change, if you cancel your booking before final invoicing, you will forfeit your deposit to cover airline cancellation charges.
04. If you cancel your booking in writing after final payment, we reserve the right to apply the following cancellation charges:
More than 56 days before departure date, deposit returned;
40-55 days before departure date, 30% cancellation charge;
22-39 days before departure date, 50% cancellation charge;
21 days to departure date or after, 100% cancellation charge.
05. Insurance is strongly recommended - if you require assistance in securing this, please contact us and we can suggest approved providers.
06. Visas to enter Israel are granted automatically to British (EU) passport holders.
07. Passports should be valid for the dates of travel and for at least 6 months after the return date.
08. Final departure flight details, along with other helpful information, will be sent to you approximately 10 weeks before departure from the UK.
09. There are no compulsory medical requirements to enter Israel.
10. All prices are based on the exchange rate of the UK Pound to the US Dollar at 1.45.
11. If you are in doubt about any of the above details or wish clarification on any point, please make contact with Walk Through the Bible or the Maranatha office at the addresses shown on this Booking Form.

Your Financial Protection

When you buy an ATOL protected flight or flight inclusive holiday from us you will receive an ATOL Certificate. This lists what is financially protected, where you can get information on what this means for you and who to contact if things go wrong. We, or the suppliers identified on your ATOL Certificate, will provide you with the services listed on the ATOL Certificate (or a suitable alternative). However, you also agree that in some cases it will not be possible to appoint an alternative ATOL holder, in which case you will be entitled to make a claim under the ATOL scheme (or your credit card issuer where applicable). If we, or the suppliers identified on your ATOL certificate, are unable to provide the services listed (or a suitable alternative, through an alternative ATOL holder or otherwise) for reasons of insolvency, the Trustees of the Air Travel Trust may make a payment to (or confer a benefit on) you under the ATOL scheme. You agree that in return for such a payment or benefit you assign absolutely to those Trustees any claims which you have or may have arising out of or relating to the non-provision of the services, including any claim against us, the travel agent (or your credit card issuer where applicable). You also agree that any such claims may be re-assigned to another body, if that other body has paid sums you have claimed under the ATOL scheme.
